Knows all Men by these presents that I Henry  
C. Wells of the County of Laurens and Territory  
of Arkansas hath bargained and sold unto Solo-  
mon Howsperth of the County and Territory  
of the said A certain Improvement or Pre-  
emption Claim of Land situate on the North  
Side of Spring River Two Miles above John  
Wells's and for an inconsideration of one  
Hundred Dollars to me in <sup>hand</sup> paid the Price  
of which I hereby Acknowledge to have  
Received I bind myself my Heirs Executors  
Administrators &c. to warrant and defend  
the title of the said Preemption Claim of Land  
or Improvement to him the Do. Howsperth  
his Heirs or Assigns In testimony whereof I  
hereunto set my hand and Seal this 20th  
of July 1820 ~
