Making & passing Court money

Fort Smith, Ark., April 9 1843

Having sworn, and examined on oath, the persons hereinafter named, I find that they severally have attended before me as witnesses in the aforesaid case, on the part of the United States, the number of days, and travelled the number of miles hereinafter specified; and that they are entitled therefor to the sums set opposite their respective names.

IT IS THEREFORE ORDERED, That the Marshal pay each of said witnesses accordingly.
