Western District of Arkansas.

Know all Men by these Presents:

That we, William Williams as principal, and Michael Lynch as sureties, acknowledge ourselves jointly and severally to owe and be indebted unto the United States of America, in the sum of One Hundred

dollars, to be levied of our goods and chattels, lands and tenements, to the use of the said United States, if default shall be made in the condition following, to-wit :

Whereas, the said William Williams was indicted at has been brought before JAMES O. CHURCHILL, a United States Commissioner for the Western District of Arkansas, to answer to the charge of the Ulay Term of the District Court of the United States for the Western District of Arkansas for Larceny and the case having been continued and upon an examination had, it appearing to said Commissioner that the offence with which the said Williams was charged had been committed, and that there was probable cause to believe the said Williams

to be guilty thereof, the Commissioner thereupon ordered said Williams to find sufficient bail in the sum of One Hundred dollars for his appearance at a District Court of the United States for the Western District of Arkansas, to be holden on the 14th day of November A. D. 1870, at the U. S. Court Room in the city of Van Buren, in said District, to answer what may then and there be objected against him ; and that in default of finding such bail he stand committed for trial.

Now, Therefore, the Condition of this Recognizance is such, That if the said Williams shall personally appear at the said Court on the first day of the next November Term thereof, at the U. S. Court Room in the City of Van Buren, at 10 o'clock, A. M., and then and there answer all such matters and things as shall be objected against him and abide the orders of the Court, and not depart the said Court without leave, then this Recognizance to be void, otherwise to be in full force and virtue.
