Biographical/Historical Note

The Berry and Hartin families were early settlers in Arkansas. The Hartin family reached Phillips County (present-day Lee County) in the early 1840s, while the Berry family settled in Woodruff County by the 1850s. John C. Berry (1835-1879) owned land in Woodruff and St. Francis counties. His daughter, Moaning Lessie Berry (1860-1934), married John Burrow Groves Hartin (1859-1912), a fellow Woodruff County landowner. They had a son, Robert Roscoe Hartin (1888-1946), who eventually moved to Jonesboro, Arkansas, and married Ruth Anna Bohrer in 1924.

This collection contains deeds, tax receipts, and other legal papers of the Hartin and Berry families from St. Francis and Woodruff counties in Arkansas.
