The Camden stave mill was one of 10 stave mills (a stave being a strip of wood forming part of the sides of a container such as a barrel) owned by W.A. Mathews and Company in 1889. W.C. White served as agent. The company's headquarters were located in Pine Bluff, Arkansas.

This collection contains material related to W.A. Mathews and Company's stave mill, located in Camden, Ouachita County, Arkansas. Items include a ledger, a promissory note, and a bill of exchange.
