GREETING:

WE COMMAND YOU, That all and singular business and excuses being laid aside, you and each of you appear and attend before the Commissioner of the District Court of the United States of America, for the Western District of Arkansas, at a Court to be held at the United States Commissioner's room, in the city of Fayetteville, Arkansas, in and for the Said Western

District of Arkansas, on the *fourth* day of *March* 187*7* at 10 o'clock in the forenoon, to testify and give evidence in a certain cause pending in the said Court, and then and there to be examined

between the United States of America and *George Kmet*

Defendent on the part of the United States.

And this you, or any of you, are not to omit, under the penalty, upon you and every one of you, of two hundred and fifty dollars.

WITNESS—E. B. HARRISON, Commissioner of said District Court, at Fayetteville, the county seat of Washington county in said District, this *5th* day of *March* A. D., 187*7*.
