We, William E Butts, as Trustee of the Branch
of the Real Estate Bank of Arkansas at Helena and
John M Burrup, W. H. Calvert, J. W. Goswick, S. Thompson
J. B. Hamely, N. H. Gentry, N. J. Martin, N. K. Sebastian, W. B. McKel-
willis Moreland, and John C. Juniper, in
his Securities, acknowledge ourselves jointly and
severally, held and firmly bound to the State of
Arkansas in the just and full sum of Thirty
Thousand dollars, for the payment whereof
well and truly, to be made, we bind ourselves our heirs
executors and administrators: Signed Sealed and
delivered this 20th day of March A.D. 1843.

The condition of the above obligation is such
that if the said William E Butts, Trustee shall
well and truly do and perform all the duties impo-
sed on him by virtue of the act entitled, "an act to
liquidate the affairs of the Real Estate Bank of the
State of Arkansas, approved the 31st day of January
1843, and shall faithfully execute the Trust by said act
conferred to him, then the above obligation to be met
and void otherwise to remain in full force and virtue
