Five Thousand One Hundred

Dollars, lawful money of the United States; for the payment whereof well and truly to be made to said BANK, or order, on or before the TWENTY-SIXTH day of OCTOBER, in the year of Christ EIGHTEEN HUNDRED AND SIXTY-ONE, with such rate of interest on said sum as the CENTRAL BOARD OF DIRECTORS of said BANK shall require, not exceeding six per cent. per annum, payable half-yearly, I bind *myself* heirs and legal representatives, firmly by these presents.
