Biographical/Historical Note

The companies of Hellen, Moog, and Company and Leavens, Malone, and Company were located in Mobile, Alabama, during the mid-nineteenth century. Hellen, Moog, and Company was a general commission merchant that sold and shipped general goods. Leavens, Malone, and Company sold cotton out of Mobile.

Scope and Contents

This collection contains business correspondence from Leavens, Malone, and Company and Hellen, Moog, and Company from Mobile, Alabama. One issue of the 'Merchant's Exchange Prices-Current' produced by the Hellen, Moog, and Company detailing the prices of planters, exports, stocks, produce, and a list of vessels that port in Mobile.
