The above named defendant was admitted to bail by Court Pick. The bond was afterwards found to be worthless and a warrant issued for his re-arrest. The Deputy proceeded to near Colbert Station C. W. and arrested said defendant. On his return by R. R. to Muskogee the Deputy found that Court Pick had gone to Washington. The Deputy was delayed at Muskogee by high water until the 10 th day of April and arrived at Fort Smith on the 12 th of April.
