Biographical Note

Harold L. Ickes (1874-1952) served as U.S. Secretary of the Interior and was responsible for implementing much of President Franklin D. Roosevelt's "New Deal." He was in charge of the Public Works Administration. Junius Marion Futrell (1870-1955) was the thirtieth governor of Arkansas, as well as a circuit and chancery judge. He was governor during the Great Depression.

This collection consists of two letters from Harold C. Ickes, Federal Emergency Administrator of Public Works, and Chairman of the National Resources Board, Washington D.C., to Governor J.M. Futrell, dated July 12, 1934-January 8, 1935.
