Fort Smith, Ark., July 17th 1889

THE UNITED STATES,

Having sworn and examined on oath the persons hereinafter named, I find that they severally have attended before me as Witnesses in the aforesaid case, on the part of the United States, the number of days, and traveled the number of miles hereinafter specified: and that they are entitled therefor to the sum set opposite to their respective names.

It is Therefore Ordered, That the Marshall pay each of said Witnesses accordingly.
