MAY TERM, 1884.

Monday Morning, *9* O'clock *May 12* 1884

Court met pursuant to adjournment: Present—The Honorable I. C. Parker, Judge of the District Court of the United States for the Western District of Arkansas.

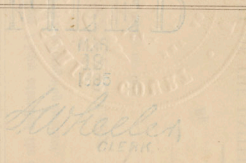
