IN THE DISTRICT COURT OF THE UNITED STATES FOR THE WESTERN DISTRICT OF ARKANSAS: MAY TERM, 1884.

Monday Morning, 9 O'clock, May 19 1884

Court met pursuant to adjournment: Present—The Honorable I. C. Parker, Judge of the District Court of the United States for the Western District of Arkansas.

Ordered by the Court that the following sums of money annexed respectively to the names of the following persons be paid them by the Marshal of this District for their fees, and compensation for services by them rendered, and travel performed, as witnesses in behalf of the United States and in behalf of defendants at the expense of the United States, in the District Court of the United States for the Western District of Arkansas, at the present term of said Court, to-wit: Harvey J. Hampton one days attendance, 110 miles travel, amount, \$ 700

I, STEPHEN WHEELER, Clerk of said Court, do hereby certify that the above is a true copy from the record. In testimony whereof I have hereunto set my hand and affixed the seal of said Court at Fort Smith, in said District this 19 day of May 1884.

I certify that the above account was presented to me on the 19th day of May 1884, and was not paid for want of funds, and that the want of funds is without any fault or negligence on the part of the Marshal.
