IN THE DISTRICT COURT OF THE UNITED STATES FOR THE WESTERN DISTRICT OF ARKANSAS:

MAY TERM, 1884.

Tuesday Morning, *9* O'clock, *June 10* 1884

Court met pursuant to adjournment: Present—The Honorable I. C. Parker, Judge of the District Court of the United States for the Western District of Arkansas.

Ordered by the Court that the following sums of money annexed respectively to the names of the following persons be paid them by the Marshal of this District for their fees, and compensation for services by them rendered, and travel performed, as *Pelit* Jurors in the District Court of the United States for the Western District of Arkansas, at the present term of said Court, to-wit: *Wm J Omeal* *Forty three* days travel and attendance, *340* miles travel, amount, \$ *103.00*

I, STEPHEN WHEELER, Clerk of said Court, do hereby certify that the above is a true copy from the record. In testimony whereof I have hereunto set my hand and affixed the seal of said Court at Fort Smith, in said District this *10* day of *June* 1884.
