Biographical/Historical Note

Union County (Ark.) was founded on November 2, 1829, from portions of Clark and Hempstead counties. It is located in south central Arkansas. It includes the cities of El Dorado, Strong, Huttig, Junction City, Norphlet, and Smackover, and the towns of Felsenthal, Calion, and Urbana. It also includes the unincorporated communities of Mount Holly, Old Union, Lawson, New London, Lapile, Moro Bay, and Parkers Chapel. El Dorado is the county seat and the largest city in the county. El Dorado experienced an oil boom in the 1920s, which increased its population. Oil production eventually tapered off, but oil and timber are still important parts of the city's economy. At the time of the 2010 Census, the population of Union County was 41,639.
