In the District Court of the United States for the Western District of Arkansas: May Term, 1886.

Friday Morning *8* o'clock *May 9th* 1886.

Court met pursuant to adjournment: Present—The Honorable I. C. Parker, Judge of the District Court of the United States for the Western District of Arkansas, when the following, among other proceedings, were had to-wit:

Ordered by the Court that the following sums of money annexed respectively to the names of the following persons be paid them by the Marshal of this District for their fees, and compensation for services by them rendered, and travel performed as witnesses in behalf of the United States and in behalf of defendants at the expense of the United States, in the District Court of the United States for the Western District of Arkansas at the present term of said court to-wit: * * *
