I, Will Clardy of A. Smitham in the County of and District aforesaid, being duly sworn, depose and say, that on the 17 day of Nov 1891 I was employed under and by virtue of the third section of the act of Congress of June 14, 1858, by Rufus Cannon U. S. Deputy Marshal for said District, at my usual place of residence, as one of his posse comitatus, to assist in executing the following capias writ, to-wit:

issued by Stephen Wheeler U. S. Commissioner for the Western District of Arkansas within the jurisdiction of the said District, returnable to the office of said Commissioner at Arkansas Nov 6 1891 and that as such posse comitatus, I immediately proceeded in company with said Marshal to Brown Store I.D.,

20 miles - where we arrested Henry Fay Nov 29 1891 - thence to Neal Sacred Breast I.D. - 35 miles - where we arrested Robt Rossie Nov 30 1891 - thence returning

to A. Smith Ark Dec 8 1891 before U. S. Commissioner, that no posse comitatus could have been employed at a nearer point to the place where the said Deputy informed me where he expected to find the said

than my place of residence aforesaid; that I actually traveled from my said residence to said place of arrest, for the purposes aforesaid, 55 miles, and in the transportation of said defendants was actually and necessarily employed 19 days as set out in the foregoing account as posse comitatus, solely in the execution of said processes and transportation of said defendants as aforesaid; that I furnished the means of or actually paid for my own travel or transportation; that I have never received or been paid, or agreed to receive, or expected to be paid any other compensation, remuneration or consideration, whatever, for said expenses and 19 day's services from any other person or persons, or sources, whatever; so help me God.

Subscribed and sworn to before me this 19 day of Dec 1891 by the above-named Will Clardy

who personally appeared and was by me known to be the identical person he represents himself.

I Rufus Cannon do solemnly swear that I am duly and regularly commissioned as a Deputy U. S. Marshal for said District; that the employment of a posse comitatus at Ark Ark under the Act of Congress of June 14, 1858, was actually and indispensibly necessary to enable me to serve the warrants in my possession, and that I could not without great peril have attempted to serve the warrants entrusted to me without the assistance of a posse comitatus; that I have examined the within account and certify that the services were performed and actually rendered as therein stated, and that the amount charged therefore is just, and that I have no interest in the same.

Marshal for the Western District of Arkansas, do certify that I have carefully inquired into the matters as set forth in the foregoing affidavits, and that the matters and things therein set forth are true, and the services of the posse comitatus employed by my Deputy were absolutely necessary to the due and proper service and execution of said warrants for the period of 19 days; and that a posse comitatus could not have been obtained any nearer than the place said posse comitatus was employed, and this account is approved for \$ 57.00
