State of Arkansas  
County of Sevier | Sct. In the County Court of Sevier  
County, July Term July 26th A D 1848

This day it appearing to the Satisfaction of the Court, that the sum necessary to be raised by taxation to defray the current Expenses of this County for the year 1848, will be about the sum of Eighteen hundred dollars; It is therefore ordered by the Court, that there be levied and collected on all the objects of Taxation for State purposes one fourth of one percent; the amount assessed by law as a State Tax

And also as a County tax on all the objects of Taxation, for County purposes, one fifth of one per cent also a Poll tax on every free white male Inhabitant of this County, over the age of twenty one years and under forty five, the sum of one dollar, on all criminal corrections, the sum of three dollars, on each and every original writ and Execution if sued out of the several courts of this County and on all certificates of Record from the office of the Recorder, the sum of fifty cents; On all Peddlers peddling clocks in this County, the sum of Twenty five dollars; And on all Peddlers peddling goods wares and merchandise the sum of Twelve dollars and fifty cents

In Testimony that the above is a true and complete copy from the Record of the County Court of Sevier County in the State of Arkansas of the order made by said County Court, on the 26th day of July 1848. Levying the rate
