Know all men by these presents,
that we, James b. Wilson, as principal, and Vincent Wallace,
William W. Floyd, Marrin B. Street, Abraham Luster, Olinver Basham,
Robert H. Brown, Newton W. Brown, Edwin Edwards, Isaac A Walton & Philip May,
as his securities, are held and firmly bound unto the State
of Arkansas, in the full, just and penal sum of Seven Thousand
dollars, which said sum, will and truly to be paid, we bind
ourselves, our heirs, executors, administrators and assigns, firmly
by these presents.

Signed with our hands, sealed with our seals, and dated at Clarksville,
on this the fifth day of August, in the year of our Lord,
one thousand, eight hundred and fifty, in duplicate.

The condition of the above obligation is such, that whereas,
the above bound James B. Wilson, was on the 15th day of
March, A. D. 1850, appointed and commissioned by the Governor
of the State of Arkansas, as Sheriff in and for the ~~]~~ said ~~]~~ County
of Johnson in the said State of Arkansas, and is by virtue of
his office as said Sheriff, Collector of revenue in and for the said
County of Johnson;

Now, if he shall faithfully perform the
duties of his office as such Collector, and shall well and truly
pay, over all moneys collected by him by virtue of his office,
then this bond to be null and void, otherwise to remain in
full force and virtue.
